 - To REPLACE Ensure a strong management committee
 BY Perform the duties of the Manager, managing event management, social media administration, and report the activities in Management Committee to Executive Committee in meetings ensuring a strong management committee.
- 4. Article 11 of Constitution Prohibitions
 - To ADD h. The association shall not involve in any commercial activities in any forms relating to supply of goods and services, and ensure the use of Curtin logo including the logo of our association is aligned with Curtin Marketing and have prior approval for use.
